ARTICLE THREE – SECTION (b) – Paragraph 2 Line 1 Now reads: Such ownership, or such residence and the purchasing of such building site under a contract or agreement of purchase, shall be the only qualifications for membership in this association.

Amend to read: Such ownership, or the purchasing of such building site under a contract or agreement of purchase, shall be the only qualifications for membership in this association.

ARTICLE THREE – SECTION (b) – Paragraph 4 Line 1 Now reads: Membership in this association shall terminate when any member shall cease to be the owner of record of a building site, or upon any member ceasing to be a resident on a building site in said property or a purchaser thereof under a contract or agreement of purchase.

<u>Amend to read:</u> Membership in this association shall terminate when any member shall cease to be the owner of record of a building site, or a purchaser thereof under a contract or agreement of purchase.

Margot spoke about a homeowner that owes dues and wants to pay partial. Michael stated they needed to contact the board.
